#### **Emergent Literacy Training Requirements**



Florida law now requires every prekindergarten classroom to have at least one prekindergarten instructor who has completed <u>three five-hour emergent literacy training courses</u>. Prior to the passage of House Bill (HB) 419 and HB 7011 in 2021, only one emergent literacy training course was required. Thus, continuing prekindergarten instructors, who have already completed one five-hour emergent literacy training courses was required. Thus, continuing prekindergarten additional courses. Any new prekindergarten instructors must take all three classes.

This legislative change became effective on July 1, 2021. The Department of Education, Division of Early Learning (DEL), gave notice of this new requirement and identified ten emergent literacy training courses that meet this requirement. Given the importance of this training, DEL set a **deadline of July 1, 2022**, for all prekindergarten providers to meet this requirement. After completing the first three emergent literacy courses, Voluntary Prekindergarten (VPK) instructors must complete one emergent literacy course <u>every five years</u>.

Instructors will receive Continuing Education Units (CEUs) upon completion of each course and the completed courses will be added on the instructor's training transcript.

VPK instructors are encouraged to begin taking the emergent literacy courses in order to complete the three fivehour emergent literacy course requirement by July 1, 2022. Contact the Redline at <u>redline@elcnwf.org</u> for more information and how to access training.

# **Child Services**

### **Updated Child Screening Process for SR Providers**

To begin alignment with Legislation and Rule for child screenings, the Coalition will be changing **annual** child screening dates from birthdays to **redetermination** dates beginning the month of April. By using the Redetermination date, this will allow the Child Screening portion of the Provider Portal to be updated in a timely manner. Please begin using your Developmental Screening Portal to access the screenings that are due.



- EFS/Mod will automatically schedule a screening and it will populate in your Developmental Screening Portal if needed.
- Occasionally if a parent or provider is concerned about a screening, the system will prompt another screening at the next screening interval to see if the child is progressing.
- If there is a request for an ASQ-3 or ASQ-SE in your Provider Portal, then a parent has not opted out of the ASQ-SE screening, and you are required to complete the ASQ-SE screening.
- Until ALL birthday screenings are filtered out, there may be duplicate screenings. For example, you may have completed a birthday screening on 2/14/22, but your Development Screening Portal is prompting you to complete a screening with a Due Date by 3/31/22. You will need to complete <u>all requested screenings</u> by the indicated due date. This will begin the alignment with the Development Screening Portal.
