

VPK Information

VPK Instructor Training Changes



In order to better support VPK educators, the Division of Early Learning (DEL) is amending Rule 6M-8.615, Florida Administrative Code (F.A.C.), VPK Training Requirements to provide clarity on course completion requirements. DEL will gather public comment on the proposed revisions at a rule development workshop on June 29, 2022. DEL will then present the amended rule and incorporated form at the State Board of Education meeting on August 17, 2022.

The amended rule revises the deadline for VPK instructors to complete the emergent literacy courses from July 1, 2022, to prior to the date of when the VPK class begins. With the removal of the July 1 deadline, instructors in 2022 Summer VPK programs will not be required to complete the emergent literacy training requirement until the following program year.

But wait...it will look a little different! We will be adding a CLASS Component too!


Our goal is to be able to support your teachers in their classroom using CLASS and FSU 10 Component framework helping promote quality care in your program.

CLASS Group Coaching (MMCI)
