#### **SB 294 – Davis/HB 427 – Nixon**

• Adds instructional hours to VPK program. The school-year program increased to 1,440 hours (average of 8 hours per day) and summer increased to 480 hours.

#### SB 916 – Calatayud/HB 929 – Trabulsy

- Aligns eligibility to State Median Income and increases to 55% SMI (equating to about 165% FPL).
- Implements a sliding fee scale (we assume as a starting point for the proposed federal rule changes) for parent co-payments to increase in percentage with a parent's income.
- Modifies the funding formula allocation to consider, at a minimum, current enrollments, eligible populations, reimbursement rates and the 22%.



### SB 1026 - Grall (no companion bill on record)

- Raises the VPK admin to 5%
- Adds language for an early learning coalition to choose to appoint an additional public sector board member in order to include a representative of local law enforcement
- Adds language regarding allowing other ways to develop a VPK providers' performance metric and restricting a provider's curriculum from including using the coordinated screening and progress monitoring program, any other progress monitoring program, or an instructional program that requires one student to one device for direct student instruction





### The Role of the Board

### **Board Purpose and Member Responsibilities**

- The purpose of the Coalition Board is to provide guidance and oversignt of the Coalition.
- Responsibilities of a member:
  - o Increase awareness of current legislative issue
  - Actively engage in Coalition Planning & Business
  - Provide visionary direction to serve additional children and support families
  - Review sub-contractor agreements for Coalition programs
  - Provide direction in the creation of a systematic infrastructure for succinct service delivery
  - "Spread the Word"- these are ALL our children...

### **Board Composition**

- The policy-making, volunteer Board must be comprised of 15-30 members and includes the following:
  - Governor appointed Chair
  - Two private sector business members appointed by the Governor
  - A Department of Children and Families regional administrator or his or her permanent designee who is authorized to make decisions on behalf of the department.
  - A district superintendent of schools or his or her permanent designee who is authorized to make decisions on behalf
    of the district.
  - A local workforce development board executive director or his or her permanent designee.
  - A county health department director or his or her designee.
  - A children's services council or juvenile welfare board chair or executive director from each county, if applicable.
  - A Department of Children and Families child care regulation representative or an agency head of a local licensing agency as defined in s. 402.302, where applicable.
  - A president of a Florida College System institution or his or her permanent designee.
  - o One member appointed by a board of county commissioners or the governing board of a municipality.
  - A Head Start director.
  - A representative of private for-profit child care providers, including private for-profit family day care homes.
  - A representative of programs for children with disabilities under the federal Individuals with Disabilities Education Act
  - A representative of faith-based child care providers.
  - Private sector business members
  - Community at-large members

### **Board Protocols**

- The Board of Directors operates under a set of approved Bylaws revised March 2022.
- The Board of Directors adheres to the requirements of the Sunshine Law
  - All meetings must be publicly noticed via website and/or newspaper
  - Board members may **not** speak to each other regarding past, present or potential board business outside of an advertised meeting
  - All documentation is public record
  - All meetings must be open to the public
  - Minutes must be taken for each meeting
  - The Coalition Board follows standard practices based on Robert's Rules of Order
- The Board of Directors has the responsibility to ensure that PUBLIC funds are used to serve children and families in each county.

### **Board Ethics and Conflicts of Interest**

- No member of the Coalition Board may participate or vote upon any measure which would inure to their special private gain or loss or that of the principal whom they represent.
- The term "participate" means any attempt to influence the decision by oral or written communication.
- It is the duty of all members to make known through verbal or written communication to the Chair and the Coalition members of all possible or apparent conflicts and to refrain from voting and/or participation regarding actions to be taken of an item with which they have a conflict of interest.
- Once a member has abstained from voting due to a conflict of interest they
  must complete and submit form 8B to the Coalition staff within 15 days of the
  vote.
