The Coalition recently applied for and received a \$10,000 planning grant from Save the Children to plan, and potentially, pilot a program in Gulf Co. called Handle with Care. The program is intended to support B-5 children and help them succeed in child care by alerting staff when a child experiences a traumatic event involving law enforcement or Child Protection Services (CPS). 4.1.4. Federal Government Shutdown Impact

The HHS plan calls for furloughing approximately 41% of staff. While immediate impacts to the Child Care & Development Block Grant (CCDBG) and Head Start programs are expected to be limited, a prolonged shutdown beyond November 1 could disrupt services, delay reimbursements, and limit agency capacity. School Readiness funding (SR) is a federally funded program through the Child Care & Development Block Grant (CCDBG). States have already received partial FY2025 discretionary awards. Because states have two years to obligate these funds and receive an annual \$3.5 billion in mandatory funding, most should be able to maintain current enrollment levels in the short term. The Division of Early Learning (DEL) has notified coalitions that it is business as usual unless there are further developments, at which time DEL will notify Coalitions. VPK is state funded and should not be impacted.
